# AIRPORT CHARGES

## *Aircrafts fees*

Due for each landing and take-off. To be calculated on aircraft MTOW (Maximum Take Off Weight) as shown on airworthiness certificate.

### **1.1 Landing fees**

Landing fees for domestic and EU/ExtraEU arrivals/destinations:

#### **Commercial and General Aviation**

### **1.2 Take-off fees**

The same as landing fees

Landing/take-off fees are doubled for General Aviation, according to Law 656, 30 November 1994

### **1.3 Parking fees**

To be calculated on aircraft MTOW (Maximum Take-Off Weight) as shown on airworthiness certificate. The first two hours free of charge.

## AIRPORT CHARGES

### *Passengers Fees*

They are due for the use of facilities and premises of common use for boarding, disembarking and reception of passengers and include also costs relative to baggage sorting, public flight information, airport flight management, CUTE and depuration. The fees are due directly by the Carrier that will charge them to passengers. They are also due by private and light aircrafts.

#### **1.4 Passengers boarding fees**

- 1) Boarding fees for passengers with domestic and international EU destinations  
for each passenger € 6,79
- 2) Boarding fees for passengers with Extra-EU international destinations:  
for each passenger € 9,02

### *Exemptions*

Passengers fees are not due by:

- children under 2 years.

### *Reductions*

Passengers fees are reduced by 50% for children from two to twelve years.

#### **PRM Assistance Fee (passengers with reduced mobility)**

- for boarded passenger € 0,99

### *Exemptions/Reductions*

Children under 2 years are exempt from payment. No reductions apply.

#### **Additional Municipal Tax**

- for each passenger € 6,50

### *Cargo Fees*

#### **1.5 Freight boarding/ discharge Fee**

- for each Kg.

€ 0,11

## SECURITY

### 2.1 Passengers/handbags Control Service

The above fee is due directly by the Carrier that will charge it to passengers, as a contribution to cover the costs of the security check on passengers and their handbags.

- for boarded pax € 2,29

### 2.2 Security checks on 100% bags in hold

- for boarded pax € 2,02

#### *Exemptions*

- Transit passengers;
- Passengers proceeding on connecting flights.

## CENTRALIZED INFRASTRUCTURES

### 3.1 Loading bridges

- the first hour or fraction of thereof parking	€ 88,92
- every 15 additional minutes	€ 22,23

#### Night stop

A flat rate equal to one hour for narrow-body aircrafts and a flat rate equal to two hours for wide-body aircrafts will be applied to flights arriving after 09.00 p.m. and departing within 06.00 a.m.

#### Note

The above fees include the use of the 400 Hz generator.
